Ocean Youth Trust Ireland is dedicated to giving young people from all walks of life a chance to go sailing and experience sail training along with the unique social, cultural and natural environment of an ocean-going vessel.

The key element of this mission is to build Social Capital through exposure to adventure, challenge and a sense of community. These all lead to giving something back to society and an opportunity for the involvement of people of all ages.

Our Approach and Why it Works

Ocean Youth Trust Ireland is a youth centred organization at who's heart is experiential learning. We do not simply take young people on a boat trip, rather we bring young people on a journey of discovery about themselves, their environment and ultimately help them to find their place in society.

Our greatest asset is our boat as we understand that Lord Rank and Four Sisters both offer a unique platform for youth development as they provide the environment for building mutual respect, self esteem, core values and a connection with the wider world.

There are identifiable processes which are taking place when we do our work. We take working with young people very seriously and our tailor made programmes are grounded in informal education and youth work theory, best practice models.

Ocean Youth Trust Ireland creates an atmosphere in which young people will learn more about themselves. The tasks of sailing a boat are reliant on team work. Our voyages are carefully planned to maximize the principles of outdoor education and nature creates an element of risk which underlies all of our work and makes the whole experience exciting and unique for every group. We are very fortunate, Ireland has an expansive coastline which we can explore, if that is not enough, there are the two thirds of the world covered by ocean which we can access.

Underlying the core elements of sailing we ultimately connect people and build relationships. We link people to themed voyages such as heritage, the arts and culture. We deliver training in house before beginning a voyage to allow comfort levels to be increased and young people to feel more confident when stepping onboard our boats.

We offer trainees an opportunity to link into the wider world of sailing and have a partner organization 'International Yachtmaster Academy' which delivers all of our maritime qualifications.

Our professional team are role models, they have a range of skills and experiences which young people learn from. A culture has been developed within the organization of challenge and reward. The crew live, cook, sleep, learn and eat together on voyages. Young people will get sea sick and they will get wet, they will feel an element of risk and nervousness however behind it all Ocean Youth Trust will nurture a safe environment in which young people will be excited and minds will be opened to new experiences and we will bring young people on a journey of self discovery.

Our Vessels

Lord Rank



The Largest of our vessels is the Lord Rank which is a 68ft yacht. Lord Rank was specifically built for OYTI using funding supplied by the Rank Foundation.

In 2008 alone Lord Rank took 478 trainees sailing over 42 voyages.

Lord Rank has taken part in 8 Tall Ships Voyages and 6 Celtic Maritime Festival Voyages.

RS Elite

These are high performance racing keelboats that can be used for day sailing sessions.

Vision XL

Job Description

Job Description:

Part Time - Community Relations Worker

Ocean Youth Trust Ireland (OYTI) have been engaging in Community Relations work for many years and more recently have been incorporating relevant OCN training into their programmes. OYTI wish to recruit a new community relations worker to further develop this area of work and engage a larger number of young people.

Job Duties:-

Location – The post holder will be based at Ocean Youth Trust Ireland's NI headquarter offices, 9 Airport Road West, Belfast Harbour Estate, Belfast, BT3 9ED. However will be required to travel throughout N. Ireland to meet and train groups.

Details –

The successful new CR post holder will design and produce an innovative 6 session CR Training and Resource package that incorporates OCN Level 1 'Community Relations and Cultural Diversity for Young People', and the outdoors, specifically sail training, as a medium for programme delivery that will be accessible and relevant to youth and community groups throughout N. Ireland. To help inform the effective adaptation of the already existing OCN level 1 course. The post holder will draw on OYTI's research and learning generated through their CRYSSS funded OCN Level 2 CR/EDI programmes.

The post holder will recruit a minimum of 25 groups working in N. Ireland who wish engage in Community Relations work and support them to engage with the newly designed CR package.

The job duties listed are typical examples of the work performed by positions at this level in OYTI but are by no means exclusive.

Principal Tasks

To: Design, Deliver, Evaluate an OCN Level 1'Community Relations and Cultural Diversity for Young People', incorporating Sail Training as the primary medium for programme delivery. To do so the post holder will need to recruit a minimum of 25 groups of 10 young people in N. Ireland who are interested in engaging in community relations work.

- 1. Consult with stakeholders to secure support for programme.
- 2. Generate database of groups and individuals who wish to get involved in OYTI CR programme.
- 3. Develop a recruitment strategy.
- 4. Develop a marketing and PR Strategy unique to this programme.
- 5. Communicate with groups, schools and churches in catchment area.
- 6. Recruit 250 young people from across 10 groups based in Northern Ireland.
- 7. Design innovative 6 session CR Training and Resource package that incorporates OCN Level 1.
- 8. Deliver training to all OYTI staff and volunteers in CR good practice to ensure delivery on board the sail training vessel.
- 9. Deliver programme to 250 interested young people.
- 10. Promote forum of Sail Training in relation to further Community Relations.
- 11. Evaluate the programme and give any feedback to OYTI, young people, community groups or parents at end of programme.
- 12. Maintain and develop a computerised and manual database for existing and potential young people from across NI in relation to legacy programme opportunities.
- 13. Design a trainee logbook to include training needs analysis, training journal and evaluation report specific to the Community Relations programme.
- 14. Communicate with staff and programme recruits on a weekly basis.
- 15. Represent OYTI at regional community relations events.
- 16. Effective monitoring of evaluation of programme activity with a view to completing weekly reports.

-helping the group to source funding to engage with the programme.
